  - 2. Three (3) winners shall each receive one (1) adult and one (1) Junior Gunner general admission tickets to the Arsenal v Bournemouth Premier League Fixture currently scheduled to kick-off on 4 May 2024 at Emirates Stadium at 3:00pm (UK Time) (the "Bournemouth Penalty Prize").
  - 3. The Prizes also include the opportunity for the winning ticketholders to take a penalty at half-time on the pitch at Emirates Stadium.
- 8. The Prize is non-refundable and non-transferable and no cash alternative will be offered. The Prize does not include personal expenditure, transport costs and other incidental costs other than those specifically included.
